The Caddo Nation Children's Clothing Assistance is funded through the Tribal Tag Office/Section 106 Programs and will award each enrolled child \$100.00, this amount is NOT tax exempt. The overall goal of this program is to assist families with back to school expenses by providing assistance for school clothes. **The deadline to submit application and paperwork is November 30, 2017.**

Eligibility

- Open to all children 18 and under that are enrolled in the Caddo Nation of Oklahoma. Pending enrollment status not applicable.

You Provide

- Copy of child/children's CDIB card or proof of enrollment
- COMPLETED application, any section not completed may be returned to you for completion and will delay the issuance of your Clothing Assistance check. Application may be submitted by mail, fax, or in person at the Tribal Administration Offices.
- If required: custody order, legal guardianship, or power of attorney of child filed in court.

Approved Clothing Items

- Shoes, shirts, pants, shorts, socks, undergarments, coats, gloves, & scarves.
- Examples of non-approved items: check cashing fee, groceries, cell phones/minutes, makeup, perfumes, colognes, hair products, tobacco, alcohol, diapers and jewelry.

Receipt Guidelines

- ALL receipts must be submitted within 60 days from the check issuance date, postmark dates will not be accepted, and receipts must be dated AFTER check issuance date.
- Copies, scanned, or original receipts will be accepted. (Please do not submit photos of receipts)
- Total or exceeds the amount awarded, receipts submitted that total less than the amount awarded will result in a denial for the next school year.
- Please list the child or children's name(s) on each receipt and NOT the parent's name. By doing this, you are ensuring that the receipts are properly credited to the child(ren) that they belong to.
